



Guidelines for the publication series *Byzanz zwischen Orient und Okzident*: Veröffentlichungen des Leibniz-WissenschaftsCampus Mainz (BOO) (as of 01.04.2019)

In order to minimize the amount of subsequent alterations, the content and form of the manuscripts submitted should comply with certain guidelines. To ensure optimum processing of your paper, please observe the following.

Text

- Submit text in Word format. Always place tables and figure captions at the end of the text or save in a separate file. Do not insert any figures, tables, etc. in the Word text. A comment should be added in the manuscript indicating where tables, etc. are to be placed in the text.
- Symbols (e.g. Greek letters, etc.) can become lost during data transfer. To prevent any problems with symbols, always use Unicode fonts.
- At the end of the article, state the full author address(es) and include all contact details (e-mail address, telephone and fax numbers).

Style guidelines

Abbreviations

- Measurement and weight units
- %; ‰; €; £; \$; § etc.
- AD (only in the case of possible uncertainties)
- BC (always state)
- c., e. g., cf., etc., i. e.
- max., min.

Dates

- Examples: 18 March 2005; from June to October 1999; during the 2001-2003 excavations
- In the text, write Jahrhundert/century/siècle in full; in notes and brackets, abbreviate century and write (Jh./c./s.)
- the numbers for centuries should be written out in full: third century and eleventh century rather than 3rd century and 11th century
- 20 000 years (reduced space)

Superscript

¹⁴C, 1st, 1^{eme}

Italics

- Latin terms/foreign terminology: e.g. *in situ*, *terminus post quem*. Not italic: villa, oppidum
- Latin quotations or quotations in foreign languages (Syrian, Arabic, etc.) in transliteration.

Numerical data

- 1.2 x 0.4 m
- diameter of 20-22 cm
- in the years 1996-1999
- 60-80 km
- between 20 and 25 m
- objects < 40 cm; objects > 40 cm (but please spell out in the main text)

- Time periods
- 540/541 AD
 - 1974-1975
 - 1930s

Numbers

- The numbers 1-12 are spelled out in the body of the document
- If a number greater than 12 is included in a list, all numbers in the list are written numerically
- In pure catalogue text, write numbers numerically

Referencing

- Footnotes are used for all literature citations. Footnote references are placed before the punctuation mark. In the case where a sentence ends with reference to a figure, the footnote should follow the figure citation but precede the punctuation: (fig. 5)⁸.
- Bibliographical references in the footnotes take the form of a short-form citation, consisting of the author's name, title keyword of the cited work and either page reference or reference to a note, figure, etc. No punctuation should separate the page range followed by a reference to a note figure, etc.
- Avoid the use of *passim*.
- For no., fig. and pl. (plate), the plural forms are nos, figs and pls
- For references to footnotes "n." is to be used.
- Multiple citations of page ranges from the same source or literature are separated by commas: Angold, Byzantine Empire 28f., 87, 133.

Examples:

The abbreviation f. is permitted, while ff. is not. Please note that f. can only be used for page ranges (of one page) and not, for example, sequences of figures, hence **figs** 5-6 (s. below). Literature can also be cited without a specific page: Cutler, Court.

- Sequences of publication citations are separated by a semicolon: Pahlitzsch, Orient 65; Tsamakda, Kreta 325.
- In case of Cyrillic, Modern Greek, etc. literature citations transcribe the name of the author. If common the title may also be transcribed into the Latin alphabet (e. g. Arabic).
- Places of publication in the bibliography should appear according to the form listed on the title page.

At the end of the article, the short-form citations are expanded into full bibliographic information in the bibliography. The short-form citation is placed before the complete entry. Apart from the exceptions defined in the enclosed Library Code List, the titles of journals, series and corpora are to be written in full. Every entry is concluded with a full stop. Not only the title but journals and series are also to be written in full (for exceptions, see Master List of Abbreviations). With articles, the complete page reference must be given. If more than two places of publication are given, use then et al. If there is more than one editor, then use (eds).

References to individual entries in exhibition catalogues (catalogue numbers):

Cat. London 2008-2009 383 Nr. 21 (A. Eastmond). [To be cited in this way in the Notes]

Only the main entry for the catalogue appears as short-form title in the bibliography:

Cat. London 2008-2009: R. Cormack / M. Vassilaki (eds), Byzantium 330-1453 [exhibition cat.] (London 2008).

Monographs:

Monographs in a series:

Source citations

All cited primary sources must be specified in the footnotes in a uniform manner.

A short-form citation must be formed from the author and the title of the work or edition.

Greek, Arabic, Russian, Syriac etc. authors and titles of works are to be transcribed in the Latin alphabet. Latinized uniform titles can also be used.

Examples for citations written in full and short-form titles derived from the titles of works or editions:

- al-Biqā'ī, Iżhār 3,81-83.
Iōannēs Kameniatēs, De expugnatione Thessalonicae 12,3.
Epistula synodica patriarcharum orientalium 10,g.
Michaēl Psellos, Egkōmiastikos 303-308.
Nikolaos Mesaritēs, Palastrevolution 14,31f..
Theodosios Goudelēs, Life of Leontios 2,34.

- As the examples above demonstrate, the relevant divisions of the work (books, chapters, titles; if a book, then in Roman numerals) are given after the short-form title,. If the work has no editorial divisions, then only the volume (if applicable) and page number are written after the short-form title followed.

List of Sources

The source editions used must be listed according to their title pages separately in the bibliography with complete bibliographical information.

- For multi-volume works: if only one volume of a multi-volume work is cited in the contribution, then only the bibliographic information (year and place of publication) for that volume need be cited. However, if more than a single volume from a multi-volume work is cited, then the entire work (including the time span in which it was published) is cited.

Illustrations

- preferably use small letters in captions
- Photographs and other half tone pictures:
width of image min. 17 cm
Resolution of min. 300 dpi
Preferably tif-format
- There are three standard widths: 8,5 cm, 13,2 cm and 17,2 cm; it is not allowed to undercut a width of 8,5 cm. Illustrations should be annotated with the standard width, which is to use. Exceptions are scale drawings and pictures.

- please scan graphic charts and drawings as 1800-dpi-Bitmap

Illustrations/Plate Captions

- as a list according to classification (a, b, c, ...; 1, 2, 3, ...)
- segregate reference and scale through “. – ” and put them at the end
- century abbreviated (c.) only in brackets
- photographic references (copyright) are given in brackets at the end of caption or in a separate list at the end of the paper

- (figs 1-2) two illustrations following one another
- (figs 1a-b; 2c. g. k) or (fig. 3; tab. 3b; pl. 5)

Illustration credits

The name of the photographer, graphic artist or source of reproduction must be listed separately.
